# 7 Important legal and technical information concerning the selection and configuration of your motorhome\_

# Configuration overview, factory sales in accordance with regulation (EU) 2021/535 (until June 2022: regulation (EU) 1230/2012)

Every motorhome is only approved for a certain maximum weight on the road, which must not be exceeded under any circumstances when driving. When selecting and configuring your motorhome or van (hereinafter referred to as: "the motorhome"), the technical and legal limits for the weight of the motorhome are therefore of particular importance. These play an important part in the configuration, especially during the selection of additional equipment (equipment packages, special equipment and options).

The technical and legal requirements for the weight of your motorhome are regulated in EU Implementing Regulation No. 2021/535 (until June 2022: EU Implementing Regulation No. 1230/2012). This applies uniformly within the European Union. In order to make it easier for you to select and configure your motorhome taking the statutory and technical specifications into consideration, please be sure to pay attention to our notes concerning this matter, which are handed to you and explained by your dealer/vendor. Alternatively, they can also be downloaded from our web site.

The vehicle weight which is calculated using the product configuration tool / price list includes the so-called weight in roadworthy condition and the so-called weight of ordered additional equipment (equipment packages, special equipment, options). It is important to note that the weight in roadworthy condition is a standard value which is specified during the type approval procedure for the respective layout. The weight that is actually measured at the end of the production line can differ in the roadworthy condition are legally permissible and possible. With regard to this, please also note that a deviation in the weight in roadworthy condition may have an impact on the number of approved seats, meaning that the number of seats may subsequently have to be reduced, a vehicle weight increase will be required and/or additional equipment may have to be omitted in order to comply with the mandatory minimum payload.

For motorhomes, European legislation prescribes a fixed minimum payload, which must at least remain for non-factory installed luggage or other accessories. This minimum payload is calculated as follows:

Minimum payload in kg  $\geq$  10 \* (n + L), whereby the following applies: "n" = maximum number of passengers including the driver and "L" = total length of vehicle in metres (including decimal places).

For a motorhome with a length of 7 m and 4 approved seats (including the driver), the minimum payload is therefore 10 kg \* (4 + 7) = 110 kg, for example.

To ensure that the minimum payload is complied with, there is a maximum combination of additional equipment which can be ordered for each vehicle model. This is expressly shown separately for each model, and must not be exceeded.

Our weight information is provided in accordance with the applicable standards and regulations. You dealer/vendor will explain how the weight in roadworthy condition, the payload, the permissible number of persons etc. are calculated. With regard to this, please observe our notes & explanations concerning the subject of weight, possible deviations, the possible increase in the weight in roadworthy condition and the payload reduction. Please read these documents carefully before selecting, configuring and ordering your new vehicle.

If, in exceptional cases which cannot be completely ruled out, the actual factory weighing of a vehicle at the end of the assembly line shows that the actual possible payload falls below the minimum payload due to a permissible weight deviation in spite of all of the precautionary measures taken by the manufacturer, we will check with you before delivery of the vehicle whether we should increase the weight of the vehicle, reduce the number of seats and/or whether additional equipment can be removed to reduce the weight. We will only deliver vehicles which comply with the legally prescribed minimum payload. Of course, you will be notified of the actual weight of your vehicle which was measured at the end of the assembly line. This gives you full transparency about any possible actual weight discrepancies in your vehicle.
